- Entrepreneurs and business owners
- Film and media
- Harvesters and traditional artists
- Manufacturing
- Tourism
- Prospectors and mining companies

### Agriculture and food production

#### [Small Scale Foods Program](#)

Funding for communities to support and promote agriculture programming in their regions.

Who can apply?

- Governments, such as municipal and local Indigenous governments; educational institutions – local or regional District Education Councils/Authorities, elementary or secondary schools, after-school programs and community-based programs.
- **Applications due:** year-round



### [Agriculture and Food Processing Development Program](#)

Various grants and contributions to support your idea or initiative for increasing food production in the NWT

Who can apply?

- NWT farmers, Food producers, Processors, Agri-businesses, Local and Indigenous governments involved in the agriculture, agri-food and agri-based products industry (this includes individuals, businesses, Indigenous organizations, industry associations and non-profit whose mandate is related to agriculture and agri-foods production or processing).
- **Applications due:** year-round

### [Agriculture Awareness Initiative](#)

Funding for activities promoting agriculture awareness

Who can apply?

- NWT residents, individual agriculture producers and agri-food processors, agri-businesses, non-profit societies in good standing and registered in the NWT, Agricultural associations, municipal and community governments, band councils, economic development agencies, or Aboriginal organizations in the NWT
- **Applications due:** year-round

### [Agriculture Training Program](#)

**Up to \$5000 per year is available** for participation in commercial agriculture oriented courses, training or conferences.

Who can apply?

- NWT residents who are experienced and/or new entrants into agricultural food production as well as agri-food processing business and/or involved in northern-based agri-businesses
- **Applications due:** year-round

### [Agriculture and Agri-Food Research Program](#)

Funding for research on new crops, production and processing techniques, value-added agri-food products and commercial forest products

Who can apply?

- NWT farmers, Food producers, Processors, Agri-businesses, Local and Indigenous governments involved in the agriculture, agri-food and agri-based products industry (this includes individuals, businesses, Indigenous



organizations, industry associations and non-profit whose mandate is related to agriculture and agri-foods production or processing).

- **Applications due:** year-round

### [Agriculture and the Environment Program Funding](#)

**Up to \$15,000 over the five year life of the program** may be contributed for activities that enhance available agriculture information and environmentally-friendly agriculture

Who can apply?

- NWT farmers, Food producers, Processors, Agri-businesses, Local and Indigenous governments involved in the agriculture, agri-food and agri-based products industry (this includes individuals, businesses, Indigenous organizations, industry associations and non-profit whose mandate is related to agriculture and agri-foods production or processing).
- **Applications due:** year-round

### [Market Development Program](#)

Marketing support and shipping cost subsidies to help your agriculture business increase its competitiveness

Who can apply?

- Eligible applicants include NWT residents who are agricultural producers, agri-food processors or involved in northern-based agri-businesses (this includes individuals, businesses, Indigenous organizations, industry associations and non-profit organizations whose mandate is related to agriculture and agri-food production or processing)
- **Applications due:** year-round – apply by Jan/Feb for projects starting April 1<sup>st</sup>

## **COVID-19 Relief and recovery**

### [Operational Support Funding](#)

Up to \$5,000 is available as a short-term buffer to assist businesses with operational costs.

Who can apply?

- All NWT businesses impacted by public health measures related to the COVID-19 pandemic.
- Applications accepted until: March 31, 2022



### [Pandemic Relief Extension Program \(PREP\)](#)

Short-term financial relief to help licensed tourism operators impacted by COVID-19 cover operational costs.

Who can apply?

- All licensed tourism operators including sole-proprietors, partnerships, and incorporated companies who meet identified criteria
- Applications accepted until March 31, 2022

### [Supplement for Tourism Accommodation Relief \(STAR\) Program](#)

Funding relief for accommodation providers in the Northwest Territories negatively impacted by the COVID-19 pandemic.

Who can apply?

- Accommodation providers offering three (3) or more rooms in the NWT
- Applications accepted until March 31, 2022

### [Tourism Restart Investment Program \(TRIP\)](#)

One-time funding to assist tourism operators and tourism-related businesses impacted by the travel restrictions related to the COVID-19 pandemic.

Who can apply?

- Tourism operators or non-profit organizations with a valid tourism operator licence, tourism-related business or non-profit organizations.
- See webpage for application deadline

## **Entrepreneurs and business owners**

### [Sector Support \(SEED\)](#)

Funding to invest in new, or expanded, facilities and equipment (capital expansion); or to expand your understanding or presence in a sector (sector research)



Who can apply?

- Indigenous organizations, business associations, municipalities, and businesses in NWT communities involved in: agriculture, energy, film, fishing, knowledge, economy, tourism, or value –added manufacturing
- **Applications due:** year-round

#### [Business Intelligence and Networking \(SEED\)](#)

**A maximum of \$8000 per year per resident or business** is available for entrepreneurs and business owners to offset costs of attending seminars and trade shows.

Who can apply?

- NWT residents and businesses
- **Applications due:** year-round

#### [Community Economic Development \(SEED\)](#)

**A maximum of \$25,000** is available for: organizations to invest in planning, infrastructure, information campaigns, and events promoting economic opportunities.

Who can apply?

- NWT Indigenous organizations, NWT-based associations, municipalities
- **Applications due:** year-round

#### [Strategic Investments \(SEED\)](#)

**\$75,000 is available annually** for projects and initiatives that directly increase employment and business and economic activity for one or more communities

Who can apply?

- NWT residents and businesses
- **Applications due:** year-round



## Film and media

### [NWT Producers Incentive Pilot Program \(PIPP\)](#)

Support for NWT producers with commercial projects at the pre-development and development stages.

Who can apply?

- NWT residents and businesses engaged in commercial film and media production that have had proven professionally funded or recognized results
- **Applications due:** year-round.

### [Support for Film](#)

Varying funds are available to support: development, marketing and promotion and sponsorship related to film and media production

Who can apply?

- Self-employed film producers in the NWT with demonstrated proficiency in the film and media arts sector
- **Applications due:** year-round

### [NWT Film Rebate Program](#)

Funding to offset costs associated with filming on-location in the NWT.

Who can apply?

- Guest producers, NWT co-production partners and NWT production companies
- **Applications due:** year-round

## Harvesters and traditional artists

### [Genuine Mackenzie Valley Fur Program](#)

One-window-access to international fur auction markets for NWT-harvested furs. (Delivered in association with supporting programs from the Department of Environment and Natural Resources (ENR))

Who can participate?

- Individuals who hold a valid Northwest Territories (NWT) General Hunting Licence, Special Trapping License, and/or beneficiaries of NWT land claims, who are residents in the NWT
- **Applications due:** n/a



### [Hide and Fur Program](#)

Access to traditional raw materials at affordable prices

Who can participate?

- Artisans in the Northwest Territories
- **Applications due:** n/a

### **Manufacturing**

#### [NWT Manufacturing Innovation and Technology Contribution](#)

Investment in technology designed to reduce costs, increase productivity, and increase local employment. (NOTE: this is a pilot program)

Who can apply?

- NWT residents and businesses with a valid NWT business license, corporate registration and permanent office in the NWT
- **Applications due:** on annually designated banking days (see website)

### **Tourism**

#### [Tourism Business Mentorship Program](#)

A program to provide applicants with an opportunity and financial support to learn skills from experienced mentors.

Who can apply?

- NWT residents with either a valid Tourism Operator License or a business, collective or organization that is engaged in the NWT tourism sector
- **Applications due:** on annually designated banking days (see website)

#### [Youth Mentorship for Tourism Program](#)

A program providing applicants with opportunity and financial support to learn skills from an experienced mentor

Who can apply?

- NWT residents between 14-18 years old.
- If older than 18, must be able to show proof of employment in tourism to qualify as a young professional; or provide a motivation letter for admission into the Program.
- **Applications due:** on annually designated banking days (see website)

#### [Tourism Product Diversification and Marketing Program](#)

A program to help you re-invent, improve, or expand your tourism product and operation to meet future market demands.



Who can apply?

- NWT Businesses, economic development agencies, and communities; Indigenous Organizations; Potential aboriginal culture tourism ventures.
- **Applications due:** on annually designated banking days (see website)

### [Community Tourism Infrastructure Contribution Program](#)

Funding for innovative tourism infrastructure projects

Who can apply?

- A municipal government, band council, economic development agency or Aboriginal organization in the NWT; a non-profit society in good standing and registered in the NWT
- **Applications due:** on annually designated banking days (see website)

### [Tourism Training Fund](#)

Funding for short-term training opportunities for tourism workers to gain new skills or to upgrade skills

Who can apply?

- NWT residents with a valid NWT Tourism Operator License; non-GNWT Visitor Information Centres; NWT accommodations-sector employees; Businesses, non-profit tourism associations or organizations; formal volunteers (festival or event)
- **Applications due:** on annually designated banking days (see website).

### [Community Tourism Coordinator Program](#)

**Up to \$50,000 annually** to qualified organizations to hire and maintain community tourism coordinators in NWT communities

Who can apply?

- Municipal councils, Band councils, Community governments, Land claim organizations, Community economic development and investment corporations, Chambers of Commerce
- **Applications due:** on annually designated banking days (see website).

## **Prospectors and mining companies**

### [Prospecting Support Program](#)

A maximum of \$5,000 over three years is available to assist in: purchasing tools and equipment; and Purchasing supplies and services directly related to prospecting activity



Who can apply?

- Prospectors with a valid NWT prospecting licence
- **Applications due:** year-round

### [Mining Incentive Program](#)

Funding for prospectors and exploration companies to support and off-set the costs of exploration projects

Who can apply?

- Companies with the legal right to conduct mineral exploration in the NWT and prospectors with a valid NWT prospecting licence
- **Applications due:** April 30<sup>th</sup> 2021

### [Work Credit Program](#)

Industry work credit of up to 150% spent on eligible exploration activities.

Who can apply?

- Mining companies performing eligible work as defined in the subsection 1(1)(a) of the *Mining Regulations*
- **Applications due:** Sept 30<sup>th</sup> 2022

## Funding Sources Available to NWT Commercial Fishers

NWT Commercial Fishers have a series of funding initiatives or programs available to them from various government departments and independent organizations. For more program information details or for information on how apply, please go to weblinks provided below.

### **Northern Integrated Commercial Fisheries Initiative (NICIFI)**

A federal initiative available through Fisheries and Oceans Canada, NICIFI provides funding and support to Indigenous groups and communities that are not eligible for the Atlantic (or Pacific) Integrated Commercial Fisheries Initiatives and in all areas where Department of Fisheries and Oceans manages the fishery. This initiative supports the development of Indigenous-owned communal commercial fishing enterprises and aquaculture operations.

The objectives of NICIFI include:

- Build knowledge and skills required to manage fisheries enterprises;
- Increase access to training to fish safely and effectively operate their vessels; and
- Build the capacity needed to meet future commercial fisheries operations, administration and training requirements independently; and
- Enhance economic returns from fisheries and aquaculture for the local and broader benefit of communities.

### **Canadian Northern Economic Development Agency (CanNor): Inclusive Diversification and Economic Advancement in the North (IDEANorth)**

IDEANorth is a federal initiative that helps enable Northerners to take advantage of northern economic opportunities to grow a strong, diverse, and sustainable economy in Canada's North. IDEANorth supports community economic growth through investments in small-scale infrastructure to allow communities and businesses to extend services and by supporting the early stages of large-scale infrastructure projects.

**Metis/Dene Development Corporation (MDDF)** has administered the Entrepreneurship and Business Development (EBD) Fund to support small- to medium-sized Aboriginal and non-Aboriginal businesses in the NWT with funding, strategic advice and ongoing administrative and financial service support.



The EBD can be used for:

- Purchasing equipment
- Starting a business
- Buying a business
- Business expansion
- Market development and promotion — including promotion, trade shows, trade missions forums, seminars and conferences.

### **GNWT-ITI: Support for Entrepreneurs and Economic Development (SEED)**

The Department of Industry, Tourism and Investment administers the SEED program funds to help organizations looking to advance regional economic development initiatives by investing in planning, infrastructure, information campaigns, and events promoting economic opportunities.

A maximum of \$25,000 of funding is available for:

- Feasibility studies, strategic plans, evaluations and planning costs that investigate economic opportunities and build on existing community resources;
- The purchase or further development of physical infrastructure (i.e. capital assets) where the lack of infrastructure constrains business development;
- Improving access to business information;
- Host and promote community-based festivals and events that highlight NWT products or talent and are key to economic development for the community.

### **GNWT-ITI: Northern Foods Development Program (NFDP)**

Aimed to increase local food production and availability of northern food products for northern consumers, the Northern Foods Program offers support across all food production sectors, including fisheries.

The NFDP aims to make investments which support:

- Community economic diversification;
- Northern food production and processing;
- Increasing local and regional agriculture and fishery participation and output;
- Encouraging/supporting local and niche food production and marketing initiatives; and
- Increasing availability of northern foods to northern consumers.

### **GNWT-ITI: Great Slave Lake Freight Support Program**

This program offsets the freight costs for transporting Great Slave Lake fish from Hay River to the FPMC Winnipeg fish plant. The program provides funding up to \$0.23/lb to help offset freight costs. An additional support of \$0.10 or \$0.20 per pound is available for remote fish freight support depending on zone origin.

Amounts are based on last year's production and deliveries to the Hay River Fish-plant and are tracked and processed through Tu Cho Fisheries Cooperative.

### **Business Development and Investment Corporation (BDIC)**

BDIC is an independent Crown Corporation of the Government of the Northwest Territories that provides a range of programs and services for the economic development of the NWT.

The BDIC promotes financial independence, assists communities in capturing economic development opportunities, and helps develop a diverse and viable northern economy.

Through BDIC, NWT Fishers can apply for NWT Covid-19 Economic Relief, term loans, standby letters of credit, working capital guarantee, contributions, and venture investments.
