2. Eligibility

This stream will be of interest to entrepreneurs and/or owner/operators of businesses who want to immigrate to the Northwest Territories and establish business operations in the Northwest Territories. All economic sectors are eligible for this program.

Business projects will be considered a priority if they involve a project that is new to the Northwest Territories or if the project would generate significant benefits to the Northwest Territories.

The Applicant must:

- · Invest:
 - A minimum of \$300,000 CDN equity* into starting or buying a business within the corporate boundaries of Yellowknife, Northwest Territories; or
 - A minimum of \$150,000 CDN equity* into starting or buying a business outside of the corporate boundaries of Yellowknife, Northwest Territories.
- Have a personal net worth** of:
 - At least \$500,000 CDN if starting or buying a business within the corporate boundaries of Yellowknife, Northwest Territories; or
 - At least \$250,000 CDN if starting or buying a business outside the corporate boundaries of Yellowknife, Northwest Territories.
- Demonstrate that they own at least one-third (33.3%) of the business.
- Where your personal equity investment is at least \$1,000,000 you may own less than one-third (33.3%) of the business pursuant to the *Immigration and Refugee Protection Regulations* section 87(6)(b)(ii).
- Have an additional \$75,000 CDN to be kept in a trust account and released upon completion of a Business Plan Agreement based on the business plan;
- Demonstrate a reasonable knowledge and understanding of the Northwest Territories and its economy;
- Be able to demonstrate reasonable communication skills appropriate to the Northwest Territories; and
- Have the necessary experience and education to successfully implement the business plan.
 - *The Department of Industry, Tourism and Investment reserves the right to determine what level of investment, if any, in a principal residence and/or vehicle will be recognized towards the Applicants equity investment requirement.
- **Net worth must be verified by an independent third party approved by the Northwest Territories Nominee Program.
